# HP tryout registration now open

One of the most-anticipated events each year is the Badger Region's High Performance Program.

Region High Performance Programs are the regional branches of USA Volleyball's National High Performance Program. Region HP Programs are operated by the USAV Region that sponsors the program in order to provide junior athletes with high-level training and skill development with some of the top coaches in that region.

This all comes at a FRAC-TION of the cost compared to other HP programs that are out there.

Many regions (including Badger Region) send teams to USA Volleyball's High Performance Championships, providing more athletes across the country the opportunity to compete in the highest level junior tournament available in the United States.

The HP Championships will take place July 18-22 in Fort Lauderdale, Fla.

This year's boys team will be coached by LJ Marx (Carthage College). At Marx's disposal will be coaches from MSOE, Marian, Lakeland and Concordia, as well as many high-level club coaches. The girls will be led by Paul Schlomer (Edgewood College) and BJ Bryant (St. Norbert).

Tryouts are March 17 for girls from 6 to 9 p.m. in the Wisconsin Center in downtown Milwaukee. A girls make-up date will be March 24, at which time the boys will have their tryouts as well.

Cost for the tryout will be \$40 for pre-registered (prior to 5 p.m. on Thursday, March 10) and \$70 for walk-up registration.


work Region events as a licensed athletic trainer whenever possible. Never in all of those years did I imagine I'd later be serving on the Board of Directors.

# Serve United program gets parents involved

The groundwork for a new program has been laid to further the Badger Region's mission to have athletes, coaches, parents and officials work together to grow the sport of volleyball and enhance everyone's experience at volleyball events.


The Badger Region staff, its board of directors and its advisory chairpersons see a great deal of benefit in this new program, title Serve United, that encourages parents to assist with "work crew" responsibilities at tournaments and other duties as the club sees needed.

As part of the Serve United program, parents can register using the discounted Badger Region Serve United membership in Webpoint, get certified as a scorer and also learn about line judging or libero tracking via the free online tutorials available through the USA Volleyball Academy. While there are not certifications for line judging and libero tracking, the rostered adult can perform that duty for a team when it is needed at tournament.

During the season, this parent/ adult can contribute to the success of the club and ease some stress on the team if they're able to step in and give a player a break to eat, rehydrate or rest.

The benefits of the Serve United program would include:

- USAV/Badger Region parent members are allowed on the playing surface to retrieve balls during warm-ups
- USAV/ Badger Region parent members can line judge during assigned "work" matches after completing the training module.
- USAV/ Badger Region parent members can keep Score/Libero



Track during assigned "work" matches after completing the training modules.

- USAV/ Badger Region parent members may decide to continue to be involved after their players "graduate" and become USAV Certified Officials — maybe once their son or daughter has completed their career on the junior
- USAV/Badger Region parent would be an additional background-screened and SafeSport-certified adult that would be around for increased child protection and safety awareness

According to the results of the 2016 State of the Badger Region Survey, parents/coaches/athletes said they would like to see more time in between matches for athletes to recover. While there are time constraints for tournaments and facilities, this program is one great way for parents to get involved to help keep the tournament moving while also providing

additional time for their team's athletes.

It's also a great opportunity for parents to step in and know what it's like to have to make the snap decisions that officials and athletes have to make on the court every play. It's always easier to ref from the sidelines — so why not step onto the court where your decisions can have a real impact.

This program doesn't allow parents to sit on a team's bench unless they are also IMPACT certified. IMPACT is the minimum certification required by USA Volleyball and the Badger Region for all coaches. (For more on IMPACT, see www.badgervolleyball.org.)

The Badger Region will fully reimburse parents who do the following:

- Purchase a USA Volleyball/ Badger Region Serve United membership (\$27) between now and April 1
- Clear their first USA Volleyball background screening (\$18),

good for two seasons

- Certify as a scorer via the USAV Academy online referee training (free)
- Take the online classes for line judging and libero tracking (free)
- Take the SafeSport online awareness class (free)
- Serve their team at matches in the various capacities
- Email Brian Sharkey (brian@ badgervolleyball.org) that you are starting your certifications
- Fill out the form that is on our website once you have completed your requirements (a copy of the form is attached to this email)

All participants who complete the tasks listed above will receive a "Badger Region —Serve United" T-shirt to help promote the program and encourage more adults to become active in their club's responsibilities to make tournament experiences better.

While this program hopes to grow the number of active adults and potential future referees, not all parents of every player in the Badger Region can be reimbursed. Therefore, we must limit the number of adults who receive full reimbursements to the first 100 parents who sign up (limit of 10 parents from the same club). Dependent on the success of the program, additional funding may be available.

# Region Championships, Qualifier fast approaching

Club directors and coaches have been busy registering for the Badger Region Championships and Qualifiers that will be taking place this winter/spring.

As of 11 a.m. on Jan. 31, there were 450 teams registered across the three weekends of the Badger Region Championships.

Some of the division also were at capacity already.

This year, the Championships are being capped at 16 teams in the Open Divisions and 32 teams in the Club Divisions.

Any teams that did not register in time for these divisions would be moved to the new Badger Division which was designed to accommodate additional teams in this ever-growing tournament.

There is still room in some of the divisions if club directors are still looking to get in the event.

Thanks to the new format and the expansion to three weekends, the Badger Region Championships will take place all under one roof at the Wisconsin Center in downtown Milwaukee this year (no off-site locations).

As of Jan. 18, all divisions (except the G12 and G13 division) had enough teams to make them a two-day tournament.

A minimum of 10 teams is required to make it a two-day tournament.

Not all teams at the Badger Region Qualifier will compete on both days of the tournament. Only teams who finish high in pool play on Day 1 of the Qualifier will move on to Day 2 of the event.

This year's Qualifiers will take place at Center Court in Waukesha and the new Milwaukee Sting Center in Menomonee Falls.

# Pair of officials earn Junior National rankings

Happy February! I sure hope the groundhog doesn't see his shadow today!

In a prior View from the Ref Stand column, we heard about the experiences and impressions of three Regional Referees who attended the 2016 USAV Girls **Junior National Championships** (GJNC) in Columbus, Ohio.

In this issue, we'll hear from two other referees — Jim Arts from Oconomowoc and Teague Prichard from Middleton — who left for the 2016 GJNC as Badger Region Regional Referees, took part in an Advanced Referee Camp, participated in their rating Teague Pritchard at work in Wisconsin Dells. session, and returned to the Badger Region as USAV Junior National Referees.

We asked them a few questions, and here's what they told us:

### How did you feel about the assistance with your preparation for advancement within **Badger Region?**

JA: The Badger Region officiating staff did an excellent job preparing me for GJNC the past couple of years.

Once I submitted my intentions, I was assigned matches that would push/challenge me to be ready to be rated. The observation/feedback sessions were very helpful in fine tuning my skills, I highly recommend these to ANY official who wants to improve their skills.

TP: Badger Region provided excellent guidance, growth and mentoring, starting several years ago, and increasing attention to detail as the years progressed. There were many National and Junior National officials within the Badger Region that provided on court evaluations and feedback, but I really enjoyed and found it extremely valuable to have a primary mentor source. Someone that is open to any question, at any time, approachable, honest, will tell you want you need to work on in a positive way and not to mention goes of the way to provide opportunities (lunch, on court evals, match opportunities, etc.). At times, each official that provided feed-



back was slightly different and at times conflicted and having a sole source of "correctness" with the latest techniques was helpful. A mentor (and guide) that cares and communicates in this manner is one of the most important



aspects to preparation.

What about your ability to work matches in the Badger Region at the appropriate level?

JA: The level of play was

very similar to higher matches that I have done here at the local level, there was some very good VB play and some poor VB play. Not too much out of the normal realm of matches. My suggestion for the camp is to have more observed matches... 2 matches/day is just not enough. Yes it was important to observe other matches, but I wish we would have had more opportunities to implement the suggestions we were given before the rating process started.

TP: Assignments for high pressure matches, including level of play and finals, builds confidence and a different experience than a pool play match. Coaches expect more, provide more feedback, pace of game, etc. These types of matches also provide you a personal reflection of whether you enjoy these types of matches and self-reflection on whether you are "ripe" for advancement as enjoying and handling these matches. I appreciated the opportunity to work with national officials during matches of this type that provided direct feedback. Jim and Julie provided additional opportunities within and outside of Badger Region that were equally, if not more valuable (NCAA scrimmages, WVC matches, etc.). Officiating these opportunities with high-level official partners is a very important aspect from an experience and feedback perspective. I also worked a number of qualifier,s and the head official also asked if there were any candidates. If yes, they were assigned with an "evaluator" and higher level matches for experience and they provided observations from afar.

### Did you have opportunities to ask questions about the process and what to expect at GJNC?

TP: Yes, without a doubt. Everyone was open, friendly, professional, and approachable. I felt I could ask most any Badger Region official questions. Jim and Julie were my go-to for all questions on USAV process, expectations, etc. Jim made many open offers for mentoring and council. At least for Jim Arts and I, I felt Jim and Julie split time, focusing on us each individually but still a large team. I felt we all had each other's best interests in mind and success was a team effort.

### What about your experience with the Ratings/Feedback at

JA: Attending the premier referee camp was one of the smartest

things I have done recently. The opportunity to showcase our skills in front of members of the USA Rating team before the actual ratings began, gave me an inside track of what specifically was being looked for and the techniques that were being implemented. The oneon-one observation meetings gave me the chance to ask questions that were specifically detailed for me. It was an actual critique of my skills/performance in rating detail form, It was exactly what I was looking for.

I had the pleasure of attending the Camp, and going through the rating session with fellow Badger official Teague Prichard. I feel this gave us a great "sounding board" for each other's questions and techniques. We have attending a previous GJNC together and knew what to expect going in. It was just another thing that we didn't have to worry about, we traveled and stayed together for both the camp and rating process. Everything went smooth (except for the snoring!).

### Did your opportunity to attend a GJNC National Championship as a Regional help this regard?

TP: Yes, one time. 2014 Extremely valuable experience. Provides a "view" of the experience you may be looking for, the level of expectations and level of play. During the tourney the feedback from national officials after each match was excellent and continue with me today. Officiating nationals without the feedback of national officials would not be nearly as valuable (e.g. just another match) This could be considered a "must" before seeking advancement to the Jr. National level.

JA: I had the opportunity to work the past (2) GJNC tournaments and feel that my experiences there provided me with a certain comfort level. I knew what to expect and could "worry"

only about what I needed to do. I highly recommend that anyone considering advancement to Jr. National seriously consider working the GJNC the year before they get rated. The experience is well worth the time.

# Was there a benefit in attending an Advanced Camp before the Ratings?

JA: Extremely high. The camp focused on the details, the protocol. The on-court evaluations identified a number of elements to work on that will be scored during ratings. It set the level of expectation in terms of details, what they look for and the level of importance. I wish we had the opportunity to officiate a few matches during the camp to apply the learned techniques in between sessions.

TP: The camp provided the latest techniques and points of emphasis. Attending the camp "should be required" in Badger Region for all candidates to help ensure success.

### Was there a benefit of attending the rating session with another Badger Region Candidate?

TP: Extremely high, before, during and after. One of the most important factors. A Wisconsin partner provides an opportunity to share stories, feedback received differently, ask each other for

feedback and clarification. It also helps during preparation including double-checking registration deadlines, applications, travel logistics, etc.

Pairing candidates with similar styles, demeanor, attitude, and "fit" is extremely important. I was very fortunate to be paired with a top-notch candidate. It could be challenging with officials from other regions with different goals, styles, etc.

# Was the level of play in your ratings matches what you expected? At a lower level? At a high level?

TP: Yes, generally. It was actually a little higher than what I was expecting.

I was also surprised how little time was spent on critiquing the "judgment areas" of ball handling, catch and throws, etc. Best guess is they expect you to know that before advancing to this level.

Was the experience worth it? Yes by all means. The entire process is a commitment but, by all means, a noticeably different level of expectation, professionalism, and attention to detail. It also makes you want to learn more, and work on the latest techniques and the art of the game.

JA: All in all, the experience was definitely worth it. A good level of stress, but it was good stress, it pushed our capabilities to a new level and I think we are better officials for it. Now it is our responsibility to pass on our new skills/experience to other officials in Badger Region. It's a team effort!

# How could we do a better job in preparing referees for advancement?

JA: An item that I feel we should be informed/trained more is protocol. We rarely use rosters in tournaments that we work here locally and training is needed for a lot of officials in this area. Adherence to protocol is a must at GJNC and we need to be comfortable with the standard operating procedures. It saves time and people watch this, especially when getting rated.

What we normally do at local tournaments is not sometimes accepted at Nationals.

Another opportunity for improvement would be to work with the Badger Region Assignor well in advance of the rating year to schedule targeted tourneys and secure dates (progression reffing) well in advance. Also, to be assigned with a national observer or work directly with another Jr. National candidate.

### Any other comments you would care to share?

TP: I feel very fortunate to have gone through the process and very fortunate to have the Badger Region leadership's support and commitment. I also feel a higher obligation to strive to be the best I can on and off the court as representing the Badger Region and a reflection of the individuals helping along the way. It goes without saying a huge thank you to Jim, Julie, and Jim Arts.

# Officials now eligible for Provisional Plus rating

Another referee certification level? What's up with that?

Badger Region is happy to formally announce the Badger Region Provisional Plus Official certification.

So, what is it?

The Provisional Plus Official certification is an extension of the Provisional Referee certification.

Why is Badger Region implementing it? The Provisional Plus Official certification is intended to recognize a Provisional Referee's commitment to volleyball officiating, demonstration of advanced and additional skills, and supporting the Badger Region.

### Why are we implementing it now?

The Provisional Plus Official certification program is being implemented at this time in order to provide a full season for those pursing the certification to qualify.

### What are the qualifications?

There are four items that need to be sat-

isfied in order to qualify for the Provisional Plus Official certification:

- 1. Has been assigned to, by the Badger Region Officials' Assigner, and completed, four Badger Region tournaments.
- 2. Has achieved a Badger Region Scorer Certification of Provisional or greater.
- 3. Has passed an observation/feedback session by a certified Badger Region trainer this season.
- 4. Has "Given a Day of Service" to the Badger Region. Examples:
- Offer four hours as a volunteer at the "Dale Rohde Memorial tournament"
- Assist with the new parent certification program
  - Mentor two in-training officials
  - Work at a Special Olympics Volleyball event
- Other service will be considered on an individual basis with approval of the Region Referee Chair

How do I apply?

Apply via an online application on the Badger Region webpage

### Will I need to recertify for the Provisional Plus Official certification?

Yes. The requirements need to be completed annually in order to maintain the Provisional Plus Official certification

### How will I be recognized as a Badger Region Provisional Plus Official?

The Provisional Plus Official will:

- Receive a gold-colored pin to be worn on the Provisional Referee patch
  - Be posted on the Badger Region website
  - Be published in the Badger Beacon
- Be noted by the Badger Region Officials' Assigner
- Other benefits are being discussed





# One big volleyball family

Playing for your local volleyball club makes you a part of a MUCH, MUCH bigger network of volleyball players, coaches, directors, officials and more. Take a look of how we're all connected:

### **USA Volleyball**



USA Volleyball (USAV) is the National Governing Body (NGB) for the sport of volleyball in the United States and is recognized as such by the Federation International de Volleyball (FIVB) and the United States Olympic Committee (USOC). The vision of USA Volleyball is to be acknowledged as the world leader in volleyball. USA Volleyball uses its 40 regions (like the Badger Region) to help implement its vision to players, coaches, sitting athletes, officials and other administrators of the sport.

USA Volleyball operates girls, boys, adult, High Performance and beach nationals to accommodate athletes of all ages and ability levels. It is also the source of numerous education resources such as IMPACT, CAP, SafeSport and officials training that is filtered down to the various member regions.

USAV is a separate organization from both the Junior Volleyball Association (JVA) and the Amateur Athletic Union (AAU). However, many (not all) of the athletes/coaches in JVA and AAU are also members of USAV.

USA Volleyball also oversees the teams that compete at the Olympics (men's, women's, sitting, beach).

### **Badger Region Volleyball Association**

Badger Region Volleyball Association is a non-profit membership organization dedicated to providing a high-quality volleyball experience to its members. As seen in last week's Badger Beacon newsletter, the Badger Region is made up of a Board of Directors elected by its members, five staff members and numerous advisory board members. The Board votes on and enforces the policies enacted by USA Volleyball and those unique to the Badger Region.

The Badger Region staff works to develop programming to enhance the experience of the junior clubs, adult clubs, officials, tournament directors and other members that the Region serves. The Badger Region staff works as a liaison between the various members and USA Volleyball, helping with registration (via Webpoint) and education (for coaches, players and officials). It also looks for opportunities to assist in the growth of the sport, especially among under-served groups.

The Badger Region also operates its own High Performance team (that competes against National High Performance teams) and its own Premier Volleyball League (PVL) team that competes at the Adult Championships.



### Junior/Adult Clubs

In the 2015-16 season, there were over 150 junior clubs registered in the state of Wisconsin (with about 20 of them being satellites of another club already established somewhere in the Badger Region) and about 20 adult volleyball clubs.

Each club is its own entity or business — many of which are non-profit organizations or other recognized IRS group. Philosophies on coaching, playing time, tournaments attended and costs to participate in a club are set at the club level.

The various clubs throughout the state are required to have IMPACT certified coaches with current background screenings, SafeSport trained coaches and have all athletes prepared to scorekeep, linejudge and officiate matches if needed.

Directors work with tournament directors to relay schedules and other tournament information (i.e. costs, parking, concessions, etc.)

Costs for jerseys, tryouts, travel and such are often determined by a club's board of directors, president or other administrators set up by the organization. Clubs must file the correct paperwork with Badger Region to be a region-recognized group.

With an athlete or coaching membership in Badger Region, you get full access to all the great resources mentioned on this page.

### Officials

Every official at a Badger Region-sanctioned tournament must be a member of USA Volleyball and have a current background screening.

Officials work closely with tournament directors and coaches to ensure that events run smoothly in accordance with the rules published in the Domestic Competition Regulations, the rulebook established by USA Volleyball.

Officials are assigned by the Region's Officials Assignor (Larry Schoenick) and work with the Officials Chair (Jim Momsen) and Officials Rating/Training Chair (Julie Voeck) to get the proper training to ref the tournaments in the Badger Region.

There are multiple levels of officials within each Region, ranging from Provisional all the way up to International.

# Tournament Directors

Tournament directors organize, market and facilitate events throughout the state. To be a recognized Badger Region-sanctioned event, the director must ensure the tournament operates according to Badger Region tournament guidelines (see our website). Tournament directors must be members of the Region and have background screenings to perform their duties.

Tournament directors report to the Badger Region Tournament Director (Terry Paulson) with results, problems and highlights from their respective competitions.

# How is the Badger Region Board structured?

The Badger Region Volleyball Association is governed by a Board of Directors that must be elected by members on a regular basis. Area reps serve three-year terms, while members of the executive board serve four-year terms.

Members, whether they are players, coaches, parents, directors, athletic trainers or officials, are encouraged to communicate with their respective representative if they

think policies or financial decision in the Region need to be changed.

Some policies enforced by Badger Region come from USA Volleyball, our sport's national governing body, so those can't be changed. But many others can.

The Board is advised by a 11 chairpersons (or experts) in various parts of the game, and five staff members (some of which have multiple responsibilities).

The state is divided into five parts geographically for representation. Plus, there are two at-large board members who you can approach if you don't feel comfortable with your current rep. And there is a rep dedicated just to issues that surround our Junior volleyball clubs and athletes.

You'll be hearing from each Board member twice a year in the form of a column in the Badger Beacon. Now, let's meet them:

volleyball world would be a logistical nightmare and require more paper and filing than we care to even think about.




