 - 2 "Intentionally vague" on hard dates, nobody enjoys the process, looking for change for the greater good

- 3 Sharkey spoke to CAP experience of other regions asking what Badger does to govern tryouts; other regions wanted more governance; Municipality involvement in San Diego
- 4 Retention of customers' needs to be a focus versus losing them to competing organizations
- 5 Thoughts shared on how it affects the athletes (not just the clubs)
- 6 Discussion on enforcement of rules/ethics/potential impacts
- 7 Perception of region governance over the clubs, "protecting" the athletes/families vs. telling clubs how to run their business

- 9 It was deemed that not enough support to move the proposal forward at this time
