Momsen

- a Staff continues to work remotely, similar to how we would in typical calendar year (thank you)
 - 1 Continue to provide good customer service
 - 2 Other regions/USAV no staffing changes as the crisis has created additional work
- b Following USAV lead when making decisions
 - 1 18s GJNC moved back to June today (3/24/20)
 - 2 USAV re-evaluates on a two-week scale
 - 3 Membership refund questions → approx.. \$4 per member (insurance \$.20)

Armson-Dyer

- a Doomsday/Worse Case Scenario forecast
 - 1 All events done for the year (BRC, BRPL, BRYFVL, etc.)
- b Balance Sheet → Contingency Fund
 - 1 Staff compiling expense elimination sheet
 - 2 Suggested moratorium on spending

Motion to impose a moratorium on spending; friendly amendment to include executive committee approval of requested expenses

Discussion on discretionary items for staff; is this included in the moratorium? Yes.

May not need a motion, just need to be responsible

- c Clarification on BRYFVL loss; this is not definite (based on membership season)
- d HP Championships
 - 1 Possible loss of up to \$17,500
 - 2 Other Regions likely not running/sending teams
 - 3 When does a decision need to be made? Within a few weeks for sure...

Badger Region Volleyball Association Mission Statement

- Facilities on "reserve" for a potential mid-May tryout
- Could a camp be run without sending teams to Championships? To generate revenue, create excitement, give kids something to do possibly, can be considered

IV Badger Region Championship 2020 Discussion (6)

Armson-Dyer / Lehman

- a Should we move forward with a re-schedule
- b Club Director survey pitching May 30-31 as new date
 - 1 65% were in favor of supporting (40 clubs)
 - 2 50 boys teams, 80-100 girls teams \rightarrow could be a strong, single weekend event
 - 3 Have we considered moving BRPL to the May 30-31, to be able to finish the league?
 - 4 Adults? Maybe...but likely not compete with USA Open
 - 5 Consideration of branching out "BRC" to multiple sites
 - 6 Refunds if we re-schedule, we will collect entry fee again
 - Don't need to hold other peoples \$ during uncertain times
 - Ease of bookkeeping
 - 7 Will there be an issue with a waitlist likely not
 - 8 How many teams needed to break even?
 - Roughly 70 teams
 - 9 Schedule again, means we may have to cancel again vs. just shutting everything down now
 - 10 Current loss of \$8500 (NetLynx trucking)
 - 11 Contract situation moving forward
 - Should be covered so long as govt order still in place
 - WCD also cannot fulfill either
 - New contracts would be needed, but if we schedule and Stay at Home orders are lifted we would likely be on hook
 - 12 Built BRC into marquee convention center, would brand take a hit?
 - 13 Liability concerns moving forward? Free-will if we are permitted to run the event
 - 14 Question of creating a NEW event Pre-National event, not named BRC
