  - Is this something the region should invest in right now with the already big loss? Is this something we should ask the families to pay for when some may already be financially hurting. Even in a normal year, the cost to the family is \$600+ and it would be around that this year.

- There was a unanimous vote to reschedule Champs. Discussion about resources and staff time, lead time for camp and to be able to do something that the members want. Perhaps put a positive spin on cancelling HP Championships, but provide a camp. It becomes more controllable by us.
- Budget wise → could look to plan budget at zero cost to region (break-even)
- If we wait until June 1, perhaps USAV cancels and it's on them instead of us
  - That's four weeks away and valuable planning time to go in another direction
  - o Concern over viability of the tournament
- No USAV timeline, depends on interest

  - Concerns over employee vs. independent contractor and if those lines would be crossed
  - Some level of maintenance/certification makes sense in line with USAV (who does the certifying) but USAV is not hiring those individuals where the region is.
  - Don't believe this is needed or warranted and puts the region at risk.
