 - 1 Transition to Sports Engine continues
 - Current memberships are coming in, 15 and up girls to come
 - Forecasting at 75% of membership from last year; some clubs not operating due to Covid-19
- c Status Updates on Programs & Initiatives
 - 1 USAV Academy Modules
 - Will be a standalone in LMS (USAV Academy); we can auto-enroll members
 - Matt Podschweit (USAV) working on building modules for refs and Jr Refs
 - New Refs and Jr Ref modules will remain the same from 2019-20
 - 2 In-Person Work Crew Requests
 - Can we provide a virtual option? Download modules without audio and have ref cadre give talking points

V Events

- a BRYFVL Update
 - 1 Very successful! 172 teams participated
 - 2 COVID Waivers & guidelines for play were very helpful
 - One confrontation with coaches; program director supported Region and replaced coaches
 - Two sites worked well (New Berlin Sports Complex & MSC)
 - 4 Two college programs officiated (Concordia & Carthage) and pool of approx. 15 referees
 - 5 Overcommunicated up front and throughout season
 - 6 Two spectators per team were allowed (were allowed to stream or record)
 - Voeck shared shout out to staff for great logistical planning (opportunities to play for athletes, BallerTV, pre-screening, etc)
 - Facilities (New Berlin & MSC) took a bit of financial hit with lack of concessions/admissions but worked very well with the region
 - 9 BallerTV some challenges with lost signals, lack of staffing, consistency, etc.
- b Badger Region Events Update
 - 1 City of Milwaukee Order 4.2 affects Wisconsin Center; currently limits to 10 people
 - 2 Facility concerns over spectators/total numbers; lack of revenue (concessions, admissions, etc.)
 - 3 150 teams registered for BRPL
 - 4 BRC tentatively 3 weekends in a row in March; approx. 300 teams registered for BRC (on hold until more clarification provided from City of Milwaukee)
 - 5 Looking into possibility of WI State Fair Park Expo
 - 6 BRQ date is set for Feb 27-28; a facility/site is interested but not yet confirmed
 - 7 BBS confirmed for 4 playdates at Adversity Training Center

VI Financial

- a PPP Loan Update
 - 1 None; automated response from BMO, no action needed at this time
- b 2019-20 Financial Status Review
 - 1 Fiscal year starts 10/1
 - 2 BRYFVL was profitable (staffing and site management in two facilities was key)
 - 3 Had a loss for the FY 2019-20, but more than \$150k less than "doomsday" prediction from March

c Budget Discussion

- 1 Membership pulled out of Juniors for next budget predictions in order to better plan
- 2 Events are guesstimates currently, very conservative
- 3 Membership projection and team fees based on 75% of last year; sanction fees 50% of last year based on a likely overall reduction in tournament offerings. All reduced to do covid predictions.
- 4 Coaching Education (AOC Premium, AVCA RAPP, \$5k misc)
- 5 Additional details can be found in the professional payment schedule
- 6 Possible boys HS grants (\$2k)
