# V Region Office / Operations

- a Questions on Staff / Event / Officials Pre-Reads\*(4)
  - 1 Curtis willing to help advocate and be part of discussions with WIAA
  - 2 Question on clubs reporting of retention offers; overall it went well
    - 25 clubs reported as using and have all athletes who accepted retention offers listed on google sheet which is view only to Club Directors
  - 3 Club Superior concerns → budget request for more offerings in addition to working with NCR to support them. Some re-education for them as to how USAV works may be needed. Kim Wudi would be willing to help and/or assist Sara (staff) with communication/training

#### b Covid / masking guidelines guidance \*(5)

- 1 Concern over the ability to enforce it; however, clubs are asking for guidance
- 2 "Strongly recommended" State/local/CDC guidelines
- 3 Club Director email → CDC guidelines, local guidelines, and/or facility rules should be followed; there will not be an official Badger Region Policy
  - Facility will need to be the ones to enforce
- 4 Stress to officials COVID protocols (no switching sides, no shaking hands, etc.)

#### VI Financial

- a PPP Updates
  - 1 PPP1 granted and forgiven; PP2 granted and in the process of being forgiven. ERC (Employee Retention Credit) was not utilized
- b 2020-21 Financial Status Review
  - 1 Cash/CDs to be reviewed; we are in a healthy place
  - 2 Membership projected loss at 14% (budgeted for 25%), mostly WVC athletes who did not register
  - 3 Dale \$4500 over budget despite being moved out of Wisconsin Center
  - 4 Juniors reeled back, but still provided services (AOC Talent ID clinics)
  - 5 Coaching Education was quiet (AOC, AVCA, etc.)
  - 6 High Performance managed well despite last minute changes to event location
  - 7 Youth (BRYFVL) will see huge profit; 205 teams registered
  - 8 Adult one-event only
  - 9 Officials moved away from in-person clinics
  - 10 BRC was a success despite getting the green light 6 days prior to first weekend
  - 11 BRO was break even
  - 12 BRPL came in just under budget; less spectators, allowed facilities to charge slightly more
  - 13 No additional feedback from finance committee (BJ & Anne)

# c 2021-22 Budget / Prof Pay Schedule Approval\*(6a)

- 1 Changes/Additions to requests
  - Coaching Education (AOC, 3C, Region Clinics) increase
    - ♦ Rushmer, Madson, Wudi all willing to help facilitate 3C
  - Region hosted clinic in Dec (ask Men's Coach, Beach, Diversity candidate) is a go! \$10k budget
  - Badger Region Boys Incentive/Support
    - ♦ Avoid losing boys clubs/teams to AAU
    - ♦ Incentivize them for competing in USAV events
    - Concern over incentivizing versus clubs wanting to play the top competition; we don't tell clubs how to run their business. Would we need to also do for girls' teams?
    - ♦ Earmark \$
