# b Non-Payment of Dues List & Legal Risk

- The delinquent list replaced the former Region Hold list (which put the Region at legal risk)
- 2 List is not publicized, but is shared with CDs upon request
- 3 Perhaps we are not always receiving the whole story from club directors, when athletes are placed on the list
- 4 Clubs (businesses) have avenues to collect funds on their own (small claims or otherwise); we don't intervene in financial disputes
- 5 Tabled for now; Ethics committee to review further in the summer

# VII Financial

- a PPP Updates
  - 1 Still in review status (60 days to respond)
- b 2020-21, 2021-22 Financial Status Reviews
  - 1 BRYFVL (2020-21 budget)
    - Three college men's teams officiated for fundraiser (MSOE, Carthage, and Concordia)
    - Estimated a good net, will be put back into youth programming and coaching education offerings
  - 2 Current financial position is strong (front loaded income; expenses occur throughout the year)
  - 3 No questions
