HOW SHOULD THE OFFICIAL HANDLE THIS SITUATION?

Scenario: The Bears are playing the Packers in a key match to go to the gold final. The match is being officiated/scored by the Packers B team. At 10-11, the coach from the Bears is concerned about the score and requests a score check. The visual and the scorebook match. The Bears are adamant that both are wrong as they are keeping stats on their sideline. The R1 comes off the stand, checks the book — nothing to report — the match carries on. After the match the coaches come to the tournament director and ask what they should have done. What are their options?

Response: The official was spot on. Noticing there was controversy with the scorebook, the official correctly came off the stand, cleared the coaches from the table area outside the 3-meter line (this helps deescalate from the start), and assessed the situation first by listening to the coach to understand



the concern, then acknowledging you understand it and let the coach know you will work with the table crew to discuss and resolve. This is where we hope the work crew's coach is in the table area for situations like this.

The scorer is the "official" score, not the visible but in this case they matched.

The official checks the scoresheet, particularly reviewing the exit scores, to ensure that there are no duplicate exit scores. Once the scoresheet review is completed, the official explains to the coach what was reviewed and the scorebook is the official score and that is what we have to go with. This is where the "art" of the game comes in as explaining the outcome in a calm and understanding way to the coach pays big dividends. If the coach disagrees with the outcome, the captain can protest. If this happens, the official should send a work crew player to the championship desk and let them know there is a protest on court X regarding the scoresheet.

For protests, the R1 goes near the officials stand and waits until the protest committee comes to you. Do not re-try to figure out the scoresheet or engage in conversation with the coach. Instruct the scorers and second referee to not discuss anything with either coach, or each other, until the protest committee arrives. Once all complete, regain your composure and continue officiating a great match with a clear mind.
