BY-LAW NOTES

- * Standing committees: Finance Committee, Nominating Committee (chaired by the Secretary), Human Resources Committee, Tryout committee, Education Committee, Ambassador committee, Communications committee
- * Meetings take place quarterly
- 1. First Quarter (Oct. 1- Dec. 31)
- 2. Second Quarter (Jan. 1-March 31)
- 3. Third Quarter (April 1-June 30)
- 4. Fourth Quarter (July 1-Sept. 30)
- * The Executive Committee is elected every four years, while other positions are elected every three years. Area reps and the executive committee receive voting rights at board meetings. Advisory positions do not.
- * Board elections take place May 1-May 10.
