1.0 Introduction and General Information

Welcome to the Badger Region adult volleyball offerings!

This manual is a guide for the Adult Team Representative. Most of the information you need to register and participate is included. Contacts are listed for any additional information that hasn't been provided. You will find the region staff and the other team reps are more than willing to help you organize and participate. We are always looking for new teams.

With several ways to participate, either through USAV "Friendship Tournaments," Wisconsin Volleyball Club/National Collegiate Volleyball Federation tournaments, or referee/score for adult tournaments, our Region provides a place where high level volleyball is being played, officiated and watched.

1.1 Getting Started

Getting started in USA Volleyball is easy. The very basics are:

- Organize six or more teammates;
- Check the website (www.badgervolleyball.org) for scheduled adult tournaments (typically January through May);
- Contact the tournament director to register for the event;

Register your team with the Region via the "Adult Team Information Form". This can be found

- There is no registration fee for adult teams.
- Have your players register themselves for as little as the cost of a one-day membership;
- Numbered jerseys are not required for in-region "Friendship Tournaments." Only for Region Championships and the USA Volleyball National Championships. Please check with the event organizer if your team is going to play in any non-Badger Region events, as they may have different jersey rules.

The rest of this document details next steps, such as registering for the entire season, playing in the Region Championships, or traveling to the USA Volleyball Adult Open Championships national event.

1.2 Further Startup Information

For teams that are going to participate for an entire season, determining your team philosophy is an important step. Your philosophy will determine how you run your team. The pre-season (fall) is the best time to answer the following:

- Who will make team decisions (a team rep, player/captain, team vote, etc.)?
- How many players will be on the team?
- How will playing time be decided?
- What tournaments will your team participate in (local, inter-regional, nationals)?
- Where is the money going to come from to register up-front, to travel, for jerseys, etc?

2.0 Season Timeline

3.0 Registration

3.1 Eligibility

Membership Requirements

Anyone playing in a USAV-sanctioned tournament must be a registered member of USA Volleyball. If a player doesn't have a membership, it will void the insurance for all other players as well as the facility. This is an important first step: to make sure all participants have a membership.

3.2 Individual Registration

Required for Players

Badger Region/USAV Individual Registration

Registration is done via an online system with credit card payments. Every person, prior to participation in any event, is required to complete this registration. Once registered and paid, members will be able to print and save their membership card, which they should take with them to events.

To register:

- Go to www.BadgerVolleyball.org and hove over "Membership" in the upper right corner.
- Click on "Adult Memberships"
- Click on the appropriate membership that is right for your
 - Badger Adult Player Membership (required if playing at nationals)
 - Badger One-Event Adult Player (required if playing in just a few Badger Region Tournaments)
 - Other memberships area available if adults are also looking to coach or be involved with junior clubs while also being an adult player
 - Summer membership (available May 1) are also available for adults. These cannot be used to play at USAV Adult Open Championships
- Follow the prompts within Sports Engine (our member management system) to sign off on waivers, refund policies and more.
- If your club uses Sports Engine to manage its roster, the Team Rep will have to send you a club invitation to you via Sports Engine that you will have to accept.

Types of Adult Memberships (Costs subject to change):

- **Regular (\$55):** Adult player who will be playing the full season (required for play at USA Adult Open Championships)
- **Collegiate (\$32):** Full-time college student for the current school year. Proof of enrollment may be requested at any time.
- **One Event (\$10 per event):** Individual registering to participate in a single USAV sanctioned event such as a clinic or tournament sanctioned as a "Friendship Tournament." One-Event members do not receive any benefits of USAV membership outside of the event. NOTE: In the required date box, put the date one day PRIOR to the event to ensure adequate time to print your membership card to take with you to the event. One-event memberships will be allowed for the Badger Region Championships. (This began in 2016.) Athletes must have their one-event membership the Wednesday before the Badger Region Championships. One-event memberships cannot be used for USAV Open Adult Championships.
- **Upgrade (\$45):** Individuals who previously purchased a one-event who would like to upgrade to the full Regular Membership. Please note, only one \$10 one-event will be recognized for the upgrade. The upgrade is \$45 regardless of how many \$10 one-events you have purchased.
- **Outdoor/Summer membership (\$15):** Individuals who register only to participate in our summer outdoor/beach events, May 1 through Oct. 31. This membership cannot be used to participate in the USAV Open Adult Championships

Team Registration

Teams usually register in the Region in which the majority of the players reside. A request to register in an adjacent Region requires approval by both Region commissioners.

Players may be added throughout the season and a team may have up to 15 players and five staff members on any given roster. However, if only one team registration form has been submitted, only one team can participate in a single tournament.

Membership Classifications:

- **Adult Player:** A player who does not meet the definition of a Junior Volleyball Player.
- **Classification:** Teams are assigned by age groups (i.e., 40s, 50s, 55s) or skill level (i.e., AA, A, BB, B). Age groups are defined by the minimum age and over. Teams are classified in order to identify their competitive level. For regional competition, the highest level of classification is AA. From highest to lowest, the following classifications can be used: AA, A, BB, B.
- **Division:** A group of teams defined for tournament competition by gender; i.e., female, male, or co-ed.
- **Club:** A combination of players and an aggregate of two or more teams of one or more divisions, and one or more classifications, registered with one Member Organization (region) under the same club name, which may or may not have the same team name.
- **Team:** A combination of players participating as a single playing unit restricted to one division and classification.
- **Club Team:** A team affiliated with a club as defined in “club” above.

Adding a Player Mid-Season

You can add players to your team at any time during the season. To add a player, simply have them register with USAV/Badger Region on Sports Engine and add them to your roster or have them bring their membership card to the tournament. Everyone on a team must have proof of membership. For help adding players to a roster who also coach a junior club volleyball team, contact the Badger Region Office (membership@badgervolleyball.org) or call 262-349-9785.

Changing teams during season

In the Badger Region, all our tournaments are considered Friendship Tournaments. This means that no players are restricted to a single roster. You may only play for one team at an event, but you may play for different teams throughout the season, in our region.

Outside the region, the rules may be different. In some regions, once a player registers/plays in a sanctioned tournament, he/she may not play on any other team in a USAV sanctioned event for the remainder of the season. Please check with the Region you are participating in to make sure you are following their rules. Exceptions could include:

- Friendship tournaments;
- Individuals on teams that are “clubbed”;
- Select divisions of the national championships.

A club is an aggregate of players with multiple teams. Each team must have a unique team name to be held for the season. The registered team name must be used for all sanctioned events. In addition, teams which are “clubbed” must also designate a club name. Teams within a club of the same level must designate a ranking for each team. Examples: Wisconsin VBC, Team Spike, Men’s A1; Wisconsin VBC, Team Dig, Men’s A2; Wisconsin VBC, Team Attack, Women’s A1, etc.

Wisconsin Volleyball Conference information

- The Wisconsin Volleyball Conference is a collegiate club volleyball conference comprised mostly of teams from Wisconsin colleges and universities. All athletes and coaches in the WVC are members of the Badger Region/USA Volleyball. Athletes and coaches who participate with teams outside of Wisconsin are USA Volleyball members in their respective Regions.
- The Badger Region provides services including, but not limited to, the following for the WVC:
 - Officials assigning for matches, playdates and tournaments
 - Tournament operations assistance and AES usage
 - Leadership training and other resources as needed
- The Badger Region financially supports the WVC in various ways.
- Wisconsin-based colleges and universities have had some amazing success on the national level. As of the conclusion of the 2022 season, the state has 19 national champion teams who called themselves WVC members. For a full rundown, click here:

Volleyball League of America

The Badger Region is proud to support Wisconsin-based athletes and teams who participate in the Volleyball League of America (VLA). The VLA has shown growth in raising the level of adult volleyball and semi-professional volleyball in the United States and continues to grow. The Badger Region supports teams from the Badger Region financially as long as they meet various criteria that include (but are not limited to): Maintaining memberships in the Badger Region /USA Volleyball, running youth clinics in the state of Wisconsin and participating in an exhibition match to showcase the highest level of adult volleyball in the Badger Region.

4.0 Tournament Information

Tournaments are one of the many reasons people join USA Volleyball / Badger Region. These are fun events held around the state and nation. Teams in the Region run several events a year. Plus, there are hundreds of tournaments nationwide, leading up to the USA Volleyball Open Championships over Memorial Day weekend. This event moves around the country every year and is a great way to form and keep up with friendships from around the country.

4.1 How to Enter a Tournament

The Regional Tournament Schedule is posted on the Adult page of the Badger Region website. Team Reps should contact Tournament Directors for specific entry information. Tournaments may be entered by simply sending an entry form noting the team rep, contact information, and submitting the entry fee. Send your Team Roster to the Tournament Director in the manner they request it in.

No team/individual will be allowed to participate in any event without verification of their USAV/Badger Region membership. A team that shows up without having previously provided the required information or without having it available prior to the start of the event will not be allowed to participate. This is for insurance and safety purposes.

A Tournament Director is required to notify a team within five (5) days of receipt your entry whether your team has been accepted into the tournament, on a waiting list, or the tournament has been filled.

4.2 Uniform Rules

For non-Friendship Tournaments, numbered jerseys and standard uniforms are required. Specific rules regarding player uniforms can be found in the USA Volleyball Indoor Domestic Competition Regulations. Jerseys and shorts must be uniform, except for the libero. The libero jersey must contrast with the other players. Numbers must be a minimum of 4" center front and 6" center back. Each player must have a unique number, 1 through 99. Duplicate numbers are not allowed. Numbers must be permanently attached. The numbers must be contrasting in color and brightness. The libero's jersey must be contrasting.

In the Badger Region, most adult tournaments are sanctioned as "Friendship Tournaments." Players are not required to have numbered jerseys, though it helps a lot. (Region Championships do require numbered jerseys). The friendship tournament directors may adjust the uniform rules as they see fit. At the USAV Adult Open Championships, all jersey tops must follow jersey rules listed in the rulebook.

4.3 USAV Participant Code of Conduct

The USAV Participant Code of Conduct is included in the Individual Membership Registration process in Sports Engine. By electronically signing the form, the individual agrees to adhere to the code. Violation of the Code of Conduct will result in club/personnel/athlete sanction(s). The USA Volleyball Guidebook (available at www.usavolleyball.org) can offer specifics about the code of conduct. It's a good idea to at least check what you've agreed to, specifically as it relates to conduct at events, alcohol, and misrepresenting your identity, among the other requirements.

4.4 Team Officiating at Tournaments

Teams are responsible to provide a six-person work crew during a tournament. This includes an R1 (up referee), an R2 (down referee), two line judges, a scorer, and a libero tracker/score flipper. Some tournaments will supply a first referee. A Certified Region Official will typically conduct playoff matches, as the region pays the officials for semi-final and final matches in playoffs. The Tournament Director must request this from the Region office at least three weeks in advance to guarantee availability of an official or officials.

4.5 Tournament Site Regulation Violations and Sanctions

Fines will be assessed to teams violating tournament protocols, such as:

- Failure to fulfill their officiating duties.
- Leaving before playing all scheduled matches.
- Canceling after the Sunday before the event.
- Failure to show up on the tournament date.

In addition, a tournament director is not obligated to refund entry fees if additional expenses were incurred in expectation of the withdrawing teams competing.

Tournament-event hosts have the right to enforce penalties for violations of facility regulations that may be set by the facility owners or the Tournament Director. The violations may include but not be limited to the following:

- No food, drink, or coolers are allowed in or around gym or playing area;
- Excessive garbage that is not properly disposed of;
- Any damage incurred to the facility and/or its property;
- Any use or possession of alcohol or drugs on facility grounds.

Violations and penalties applied need to be reported to the Region Tournament Director on the Tournament Report Form.

4.6 Badger Region Championships

The Badger Region hosts a regional championship for men's and women's teams at levels that have a minimum of three (3) teams registered for that event. Teams should enter using AES (www.AdvancedEventSystems.com). Only teams that meet the posted entry deadlines will be accepted. The region may combine levels in order to run an event that is short of teams. Payouts will be made to winners of each division based on the number of teams who enter the tournament.

4.7 Out-of-Region Tournaments

Contact the tournament director office for help if you plan to play out of region. One-event members may not be accepted for these events.

National Collegiate Volleyball Federation (NCVF)

NCVF is a non-profit organization formed in cooperation with volunteer collegiate club volleyball commissioners and representatives throughout the United States. It is the only nationally oriented organization in the U.S. formed specifically to promote yearlong organized collegiate club volleyball opportunities for men and women. The national NCVF website is <http://ncfvolleyball.org>.

Locally, the Wisconsin Volleyball Conference (WVC) organized statewide participation in NCVF tournaments. Contact the WVC at www.wvcweb.org for more information about participation.

USAV Open Championships

The USAV website, www.usavolleyball.org, has information on the USAV Open Championships. Teams that are interested in participating should get a copy of the Pre-Tournament Manual for information on eligibility, entry process and deadlines, and hotels.

Open Championship Team Level of Play Definitions:

- **Open-Division Teams:** Teams composed of players from any source who are highly skilled, elite level players. Teams entered by invitation only.
- **Club Division Teams:** Teams composed of players mostly from the **same** region. USAV allows two players from another region on a team roster. Club Classifications are by skill, AA, A, BB, B. Teams select their own skill levels with region approval.
- **Masters and Seniors Division Teams:** Teams composed of players who meet the approved minimum age. Teams may be a conglomerate, from any region.

4.8 Hosting a Tournament

Badger Region will welcome any member who interested in running an adult tournament.

Anyone who is interested in hosting a tournament may download the **Badger Region Tournament Director Handbook** from the Badger Region website. The handbook includes information on Tournament procedures beginning with getting the event sanctioned by submitting the **Application for Tournament Hosting**. Once your adult event has been approved, the Region will add your event to the Tournament Schedule on the website under "adults". The Region Tournament Director will also assist you in the process from managing the event through reporting results. The Region Tournament Director must approve any variances from published formats and guidelines. A Tournament Director is not allowed to publicize their event until regional approval has been granted. For safety and insurance purposes, everyone involved in the tournament must be a member of USA Volleyball: Tournament directors, site directors, coaches, players, or anyone else who sits on a team bench or scorers' table.

To encourage adult teams to host tournaments, the Badger Region will pay the cost of the certified officials for the semi and final matches for all events.

The Badger Region will also work provide a Site Director for new tournament hosts to help with team check-in, formats, questions, etc. (This can be requested but is not guaranteed.) At the conclusion of the tournament, directors are asked to email results to brian@badgervolleyball.org, and they should also indicate any issues that might have occurred at the event. Do not mail scoresheets to the office.

4.9 Friendship Tournaments

Adult tournaments in Badger Region, other than the Regional Championships, are sanctioned as “Friendship Tournaments.” This format allows players to move from one team to another. It also allows non-full Badger Region/USAV members to participate as One Event members. Individuals must complete the Badger Region/USAV Membership online registration and take their membership card with them to the event.

Tournament directors must check that all members of a team have proof of membership, whether they are on the team’s official roster or have a one-event membership card encompassing the corresponding dates. One-event registrants are encouraged to put in the “event date” box the day PRIOR to the event to allow for adequate time to print the membership card.

Uniform rules may be relaxed for Friendship Tournaments, according to the Tournament Director. When using a libero, the player needs to be clearly recognized.

5.0 Insurance

All members are provided both liability and secondary sport accident insurance as a benefit of your membership with Badger Region / USA Volleyball.

5.1 Summary of Coverage for Secondary Sport Accident Insurance

All members registered through Badger Region while functioning on behalf of or while participating in a sanctioned event are covered for accidental injury that occurs while participating in USA Volleyball sanctioned events. *Actual coverage is detailed in the policy at www.usavolleyball.org and is subject to the conditions contained therein.*

5.2 Injuries

All team reps, coaches and tournament directors should have a few copies of the **Incident Report Form**, printed on goldenrod paper, available. The team rep, tournament director, or Badger Region/USAV representative at the scene or upon notice of an incident resulting in bodily injury or property damage, shall obtain and record the information required on the Incident Report Form. These forms must be submitted as the incidents occur, following the instructions on the form.

If the individual injured requests to apply for the benefits under the Accidental Sport Coverage, they should be given a **Medical Claim Form**. The injured participant must complete the form completely and sign the first page of the form. If the injury requires medical attention by a physician, nurse, or health care provider, follow the instructions on page 2 of the Medical Claim Form. The form shall then be submitted as noted on the form.

5.3 Liability Insurance/Certificates of Insurance

Your program, as a member of USAV/Badger Region, is provided with liability coverage for your events. Prior to the start of your season, send the **Certificate of Insurance Request Form** to the region office. List all the facilities your club / team will use during the season for tryouts, practices, tournaments, etc. This will notify our office of the facilities that you will need covered for liability. If you check off that your facility requires a Certificate of Insurance, the region office will secure that certificate for you. If your facility requires that they be listed as "additional insured," you need to note that on the form as well. Certificates of Insurance will be sent to the Team Rep via email.

The liability insurance is only valid if all participants are members of USA Volleyball. For details, go to www.usavolleyball.org.

If you are renting a facility, you should read over very carefully any rental agreements or contracts before signing them. Be sure you are only taking responsibility for the area of the facility you will actually be occupying for your event. If you have questions about the agreement and would like our insurance broker to review the contract, contact the region office. The Certificate Holder (facility owner) is only an additional insured with respect to liability caused by the negligent acts or omissions of the Named Insured (club or TD) as respects to sanctioned USAV and Badger Region Volleyball events.

Tournament and Team Reps should review any contracts they sign for facilities. If there are any questions on contract language, please reach out to the Region prior to signing the contract, and we will get you in contact with the USA Volleyball liability insurance company. They will help review the contract for any USAV Region-registered club or event. This must be done before the contract is signed.

6.0 Ethics and Eligibility Issues

Team Reps and their members have an obligation to be familiar with the rules, guidelines, and ethics codes of Badger Region and USA Volleyball. Lack of awareness, misunderstanding of a rule or standard, is not a defense to a charge of wrong doing. When a Team Rep is uncertain whether a particular situation or course of action would violate policy or ethics, the director should consult with knowledgeable authorities.

When a member believes that there may have been a violation of the policy or ethics by another member, they should attempt to resolve the issue by bringing it to the attention of that individual if an informal resolution appears appropriate and when intervention does not violate any member rights that may be involved.

If you feel a violation is not appropriate for informal resolution or informal resolution did not resolve the violation properly, you may need to file an official grievance. The steps for this process are:

1. Contact the Board Member that represents your area (found on the Badger Region website). If you feel there is a conflict of interest between the party with the grievance and the Area Rep, contact the Region Office or the Adult Chairperson.
2. Your Area Rep may attempt another informal resolution of the violation.
3. If informal resolution fails again or is not appropriate, your Area Rep will notify the Badger Region office, who will assist you in filing the grievance with Badger Region.
4. Complete a **Badger Region Ethics & Eligibility Report** (<https://badgervolleyball.org/violations-or-ethics-reporting-form/>). The form should be submitted with any supporting documents and the report will be forwarded to the appropriate Ethics and Eligibility Committee for review. The Ethics and Eligibility Committee will follow the procedures outlined in the **Badger Region Ethics & Eligibility Guidelines**, found on the region website.

Team Reps and members of USAV/Badger Region must cooperate in Ethics and Eligibility investigations, proceedings, and resulting requirements. Failure to cooperate is itself an ethics violation.

Teams and their players do not file or encourage the filing of complaints that are frivolous and are intended to harm the respondent rather than to protect the public.

7.0 Player Representation

7.1 Badger Region Board of Directors

The Badger Region Board of Directors is elected by a vote of the general membership. All Adult regular members are eligible and encouraged to vote. A call for nominations is sent out via e-mail and posted on the website each spring. We are always looking for new ideas and perspectives on our board. Please contact the Region office if you are interested in serving in this capacity.

7.2 Badger Region Adult Player Rep

The Adult Player Rep is appointed by the Badger Region Board of Directors and is a member of the Board of Director's Advisory Committee. The Rep has voice but no vote at on the Board of Directors. The Adult Player Rep is your representative to the leadership of Badger Region, responsible to bring issues related to adult player programs to the Board. We strongly encourage anyone who has suggestions on policy and procedure related to adult programs to bring them to the attention of the Adult Player Rep. The Adult Player Rep will also serve on the Ethics and Eligibility Committee for adult issues.

Teams that are responsible to provide a work crew during a tournament must provide the following: a R1 (up referee), a R2 (down official), two lines persons, a scorer, and a libero tracker/score flipper. Players who are assigned to work need to provide the best service possible for the teams that are competing.

Clinic dates, locations, and times will be posted on the website. Please make sure that all athletes and coaches are versed in scoring, line judging and officiating all aspects of the game before your first competition.

Badger Region is always looking for certified officials. If any of your players are interested in officiating or scorekeeper, contact the Officials Chair or check the website for more information. It is a great way to earn some extra cash while participating in a great sport.
