## Compensation increased for Badger Region-hosted events

The Region understands that you have a choice of where to officiate and we wanted to increase pay and benefits to show our appreciation. While we acknowledge these rates are likely not as high as some for-profit events are paying, we are indeed a nonprofit organization and the funds that we collect from our events goes back into programming, training and providing opportunities across the state of Wisconsin.

We appreciate you officiating

with us in the Badger Region!

In the coming months, the staff will be talking with tournament directors and collecting data to examine the proposal of raising ref pay across the board for Badger Region-approved events. These are the ones that are run by clubs and universities that, while the Region does not pay for the officials, we assign officials and provide assistance to the tournament directors, and therefore raising the pay

affects more than just the Region budget. These events are often supported by the smaller clubs in the Region, and we appreciate your hard work at these events. While they may not be in large convention centers or have a lot of courts, they are just as important to serve all different parts of our membership throughout the state.

#### Our event rates

At the last Badger Region Board meeting in early November, board members voted in favor of raising the ref pay at Region-hosted events (Badger Region Championships / Dale Rohde Memorial Boys Event, Badger Region Qualifier, Badger Region Power League) to the following pay scale:

- \* Provisional- \$31
- \* Regional- \$33
- \* JN/National- \$36

## Assigning has begun for events; reminder to update Zebraweb

Assigning is underway for Badger Region events including the Badger Region Power League, Championships and the Badger Region Qualifier.

If you are interested in working any of these events, please unblock your calendar for the desired dates, and reach out to Sara (sara@badgervolleyball.org) with preferences or any type of limitations on match count, waves, etc.

Officials, if you accept an assignment from another assigning system, that will not reflect in your Zebraweb account. Please block your dates in Zebraweb so you are not double-booking your officiating dates.

All zebraweb memos that are sent are automatically saved and can be accessed on your main welcome page in your Zebraweb account. It's a great way to look back if you need to revisit past content or links.

Zebraweb alerts can be sent to your phone. You can set this up on the main profile page on your Zebraweb account.

NOTE: When you are given an assignment don't forget to click on the notes link (if applicable) to see any special details or information about the tournament before you accept. Assigners use the notes are to enter important information regarding the tournament.

### **UW-O** teams up for ref training

Picking up from where we left off before COVID, the Badger Region Staff traveled to UW-Oshkosh last week to do some "new official" training for the NCAA women's team in order to allow them to officiate their hosted club tournaments.

"The training was done quite a bit at different colleges before COVID so we are happy to start bringing it back," said Badger Region ref assigner Sara Voigt.

Not only does this allow college teams to use their hosted junior club tournaments as fundraisers, some of the athletes may choose to officiate outside of their own tournaments, which helps with the state-wide officials shortage.

"Bringing this face-to-face training back to the college athletes is truly needed because it allows a lot of back and forth dialogue between the athletes and the trainers.," Voigt said. "It also helps build the new officials confidence when they get on the stand because of the situational training that is done during the in-person training."

Staff is planning to work with athletes from UW-Parkside and UW-Whitewater to assist them the same way. Crossing our fingers and hoping some of the athletes will continue to pursue an officiating career after their college playing career is over.

# Fees tied to officiating

Officials need to renew and fulfill certain requirements before being "assignable" every club season. The Region knows how confusing things can get, so here is a simple explanation of what fees need to be paid and what they are for:

The Badger Region Adult with Safety Requirements membership is \$55.88. You will see the transaction broken down into two separate payments of \$25 and \$30.88. One transaction goes to USAV. The other goes to Badger Region.

Once the membership is purchased, officials must submit their background screen through their Sports Engine account as prompted a(\$14 yearly). The last fee is the annual ref/scorer fee of \$25 that is paid to the region to cover the costs of Zebraweb, assigning, rulebooks, in-person/Zoom meetings, and additional mentoring for growth and advancement.

### Sanction reporting form online

Officials should use the Badger Region Card Reporting Form on the Badger Region website when issuing sanctions at Badger Region-sanctioned events.



The goal of this form is to help Badger Region staff, officials and board members in tracking "repeat offenders" when it comes to behavior or antics on the court. This also will go a long way into educating athletes, coaches and entire clubs who may need some reminders.

#### **BACKGROUND SCREENINGS**

All adult staff members require a full background screening that includes the following:

- \* Social Security Number validation;
- \* Name and address history records:
- \* Two independent Multi-Jurisdictional Criminal Database searches covering 50 states plus DC, Guam, and Puerto Rico;
- \* Federal District Courts search for each name used and district where the individual currently lives or has lived during the past seven years, going back the length of time records are available and reportable;
- \* County Criminal Records for each name used and county where the individual currently lives or has lived during the past seven years, going back the length of time records are available and reportable for each county searched:
- \* National Sex Offender Registry database search of all available states, plus DC, Guam, and Puerto Rico;
- \* Multiple National Watch Lists;
- \* SafeSport Disciplinary Records;
- \* Comprehensive International Records search for U.S. citizens who have lived outside of the United States for six consecutive months in any one country, during the past seven years;
- \* Motor Vehicle Records of at least a 3-year history in the state of licensure; (if driving is required for position).


### MEMBERSHIP COSTS BREAKDOWN
